Peregrine Asset Advisers (PAA) is an Investment Adviser registered with the Securities and Exchange Commission. For discretionary services, we buy and sell securities without asking you in advance. For non-discretionary services, you will make the ultimate decision regarding the purchase or sale of a security. We provide advice and make recommendations on listed stocks, fixed income investments, mutual funds, and exchange traded funds. You can place reasonable restrictions on the types of investments we make on your behalf in writing. Our account minimum is \$100,000 but is subject to exceptions. We will monitor and review your account on a regular basis.

# Item 3: Fees, Costs, Conflicts of Interest, and Standards of Conduct "What fees will I pay?"

You will pay us a quarterly management fee, that is based on the amount of assets that we manage. This is our only renumeration. This fee is charged in arrears, that is, after the management work has been performed. The fee is determined by the market value of your account at the end of each quarter, adjusted for deposits and withdrawals. The more money you invest with us the more fees you will pay; therefore, we have an incentive to encourage you to increase your assets in your account. You are also responsible for any commissions or account fees charged by the broker. Mutual funds and exchange traded funds also charge overhead expenses.

If you retire from an employer, you may consult with us on investing your work retirement plan or rolling it over into an IRA managed by our firm. We may offer to manage your assets and in doing so, you will pay additional fees, since we would be managing these assets and assessing a management fee on them.
